## 2. Summary

The BERD@NFDI consortium is dedicated to advancing Research Data Management (RDM) in the fields of business, economics, and related disciplines. These areas of study are crucial for understanding and predicting market behaviors and transformation, economic trends, transformation of business and consumer behavior and broader societal impacts. The data critical to this research are diverse, often unstructured, and derived from various sources, highlighting the necessity for robust data management practices.

At the core of our operations, the BERD Data Portal and the BERD Data Marketplace have been instrumental. These platforms not only facilitate the accessibility of high-quality data but also enhance collaborations between academia and industry by providing a structured environment for data exchange. The accreditation of our data services through rigorous open standards ensures that the data are not only findable but also accessible and usable, thereby supporting the transparency and reproducibility of research.

The introduction of specialized services, such as the BERD Academy for training researchers in handling unstructured data, legal advice in using data in research and OCR for historical business records marks a significant advancement in our consortium's offerings. These

initiatives exemplify our commitment to not only managing but also enriching the utility of data across various research domains.

BERD@NFDI's integration within the larger NFDI network has enabled the strengthening, widening, and deepening of our infrastructure and services. BERD supports the mission and development of NFDI sections, with a special focus on the sections Industry Engagement and Ethical, Ethical and Legal Issues (ELSA). This integration supports the consortium in offering professional RDM services to an expanding user base, exemplified by initiatives like our detailed metadata schemas that establish FAIRness and the standardized data management plans that aid researchers in navigating the complex landscape of data management.

Moreover, our efforts extend to the international arena. We closely align our activities with the European Open Science Cloud (EOSC) and cooperate with the EOSC Association. We reach out and collaborate with related data and analytics services initiatives such as the Wharton Data Service (WHDS) and the Coleridge initiative. These international partnerships are pivotal in keeping our practices aligned with global standards and innovations.

Despite our successes, challenges remain. The dynamic nature of unstructured data requires continuous adaptation of our tools and services. The consortium is also navigating the complexities of integrating new types of data and expanding our user base to include emerging research communities. Future efforts will focus on enhancing the accessibility and usability of sensitive data, ensuring ethical considerations are central to our RDM practices, and further developing our infrastructure to support a growing variety of data types.

In summary, BERD@NFDI is making substantial contributions to the data landscape by providing quality-controlled data services, expanding access to RDM resources, fostering community engagement around datasets, and facilitating ethical research practices. As we continue to evolve, our focus will remain on enhancing the qualifications of data curators and increasing the findability and usability of data through innovative services and collaborations. With ongoing support from the NFDI and engagement with our advisory board, BERD@NFDI is well-positioned to meet the current and future needs of the research community in business, economics, and related fields.
