As a funding recipient, your institution is required to document and demonstrate to the DFG that the funding has been used for the proper purpose. To this end, it <u>may</u> be necessary in some cases to collect and disclose to the DFG certain "special categories of personal data" relating to you.

The data required may vary depending on the individual case and could include such details as general health information, details revealing ethnic origin, information about a long-term or chronic illness, a disability or other sensitive data relating to hardship cases.

The DFG is obliged to verify that funding is used in the proper way. In order to carry out this verification, the DFG must be able to access and process the necessary information to assess whether or not the funds have been used appropriately. If anonymised data is not sufficient as evidence, this information may include personal data relating to you. Under applicable data protection regulations, it is necessary for you to consent to the processing of your data by the DFG and to provide the required information. **Your consent is always voluntary** – you are under no obligation to provide any details. However, please be aware that if you do not provide your consent, it may be the case that funding cannot be used for measures that take into account your special personal circumstances.

Please also note that project funds may be reclaimed in full or in part if the project relevance or proper use of the funds cannot be sufficiently demonstrated, documented or plausibly explained.

In the context of the Standard Allowance for Equity and Diversity, this may apply in particular to the following cases:

- The specific use of the funds is unclear
- The specific purpose of the Standard Allowance for Equity and Diversity is not plausible
- There is a lack of general evidence regarding the nature and extent of fund usage
- The individuals involved are not identified
- Personal details are incorrect or inaccurate
- Personal data has been processed or disclosed in breach of data protection regulations
- Consent to the processing of data or its disclosure to the DFG is lacking or invalid

¹ "Special categories of personal data" are those "revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, and (...) genetic data, biometric data for the purpose of uniquely identifying a natural person, data concerning health or data concerning a natural person's sex life or sexual orientation" (Article 9(1) GDPR).
