3 INTER-LINKED WORK PACKAGES

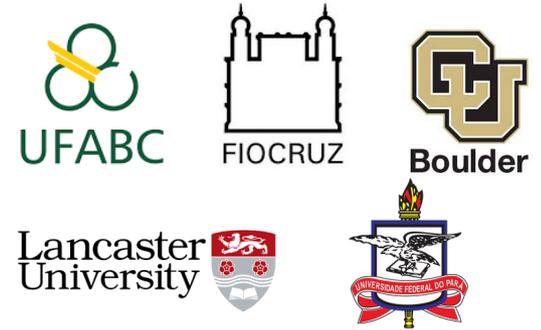
- (1) **quantify the linkages** between forest citizenship and COVID-19 resilience;
- (2) **understand practices** of forest citizenship in relation to COVID-19 experiences;
- (3) **understand and disseminate learning** on the conditions for promoting forest citizenship and enhancing disaster resilience across Amazonia.

Main institutions in these examples

Differentiated citizenship in Brazil

- Brazilian Constitution confers universal rights (e.g., to health, quality education), yet marginalized forest-dwellers often unable to achieve these.



- Might **struggles for territorial recognition and social inclusion** emancipate forest-dwellers by solidifying their **'right to have rights'** as members of Brazilian society?

Example 1a: (Re) conceptualizing forest citizenship (2-step)

- i. Status of FC.** Represents bundle of rights, with territorial recognition as a precursor. Reflects demands that individuals + groups are recognised by different state and/or multilateral institutions and socially included. Then...
- ii. Practices of FC.** A set of shifting relationships involving those with territorial recognition as forest-dwellers, related to the claiming of rights from the state & other institutions.

(Formal rights matter but must be actionable)

Phase 1b: Quantifying Forest Citizenship

- Use FC **status**: recognition of people's territorial rights as different kinds of traditional river-dwellers (sometimes plus forest conservation logics).
- We identify **territorial categories** with self-organization in creation, + participatory governance.



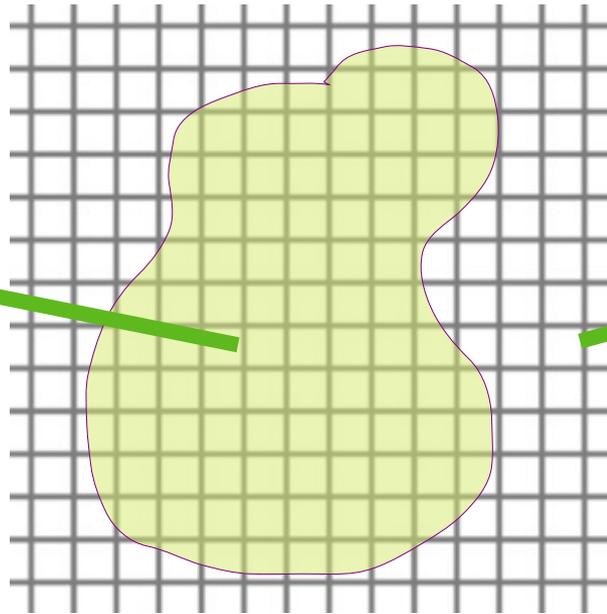
Territories inhabited by Forest Citizens

Forest citizens are subset of Forest Proximate People (Newton et al. 2020)

1) Calculate population size **in** each territory +
Forest Proximate People living **outside** territories.

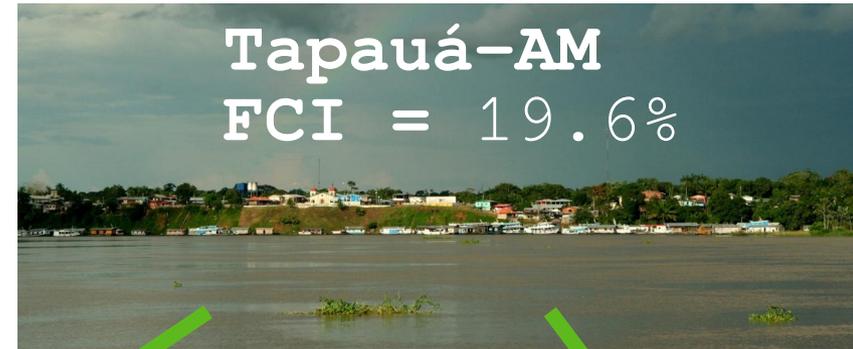
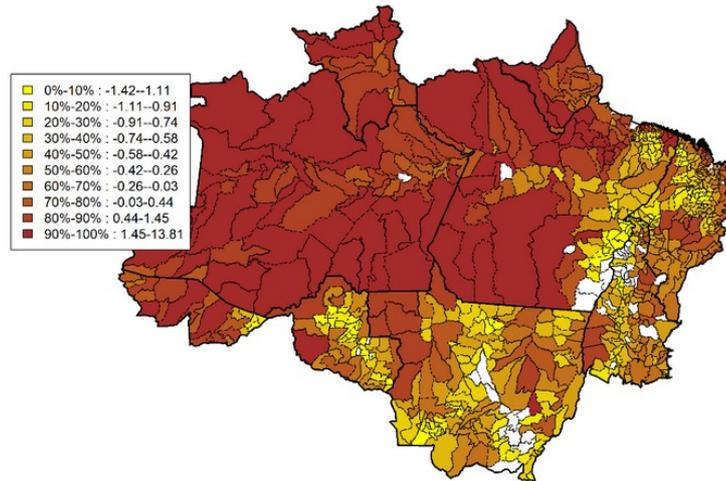

Quantifying FC intensity in municipalities

- Legal Amazon has $\sim 822,774 \pm 5,469$ forest citizens
- Overall FC 'intensity' = **12% of rural Amazonians**
- Municipalities key to service delivery and governance in decentralized Brazil

(772 municipalities)



EXAMPLE 2: Did a higher intensity of Forest Citizenship mitigate the health impacts of COVID- 19?

- Municipality-scale analysis
- Controlled for health resources (people + infrastructure), governance quality, State & NGO presence, remoteness from major cities
- 2006–2022: respiratory hospitalizations; all-cause mortality; COVID-specific outcomes



Which mechanisms might link greater forest citizenship & improved health outcomes?

- **Greater prosperity** & improved **social determinants** of health, so lower vulnerability
- Successful **lobbying** for improved access to quality **healthcare**
- Greater **presence of the State** (or NGOs), so improved access to quality healthcare
- Stronger **community cohesion, & self-organization** during the pandemic and other crises
- Stronger local municipal accountability & **better governance**, including health governance

EXAMPLE 3: Understanding rural socio-political organization & experiences during the pandemic



- Iriri Extractivist Reserve (RESEX), Pará

- Visits in Nov./Dec. 2022 & May 2023

(1) presented research proposal to the Extraordinary Assembly; obtain authorization for research; general mapping and first contacts with residents and local organizations.

2) qualitative interviews w/ residents of the Iriri Resex and Vila de Maribel (outside); obtain authorization from the community leadership to carry out the research in Maribel.

Manaus

- Visited Dec. 2022)

defined the empirical universe to be worked on in **Amazonas**. We defined the **Unini Resex**. NEXT FIELDWORK...



Community socio-political organization
(creation of the RESEX; confronting COVID-19; networks & linkages (local, external))



Experiences & changes in daily lives, households
(household relations; access to healthcare)

EXAMPLE 4: Institutional arrangements & rural healthcare provision

- Urban fieldwork in Pará (May '22) then Amazonas
- Matched to municipalities of Example 3 fieldwork
- Aims & approaches
 - Mapping actor networks offering health services to Resex populations, focusing on *Sistema Único de Saúde* (SUS);
 - Capture perceptions re: citizenship and the rights of Resex populations;
 - Map formal spaces for social participation and interests aggregation around public health services;
 - Understand pandemic impacts.

Urban (Altamira) provisional results

- **15 (fifteen) interviews** e.g. Municipal Health Department of Altamira, health NGOs, Residents Associations.
- Healthcare access for 'forest citizens' not seen as guaranteed or recognized right by local government. Instead, healthcare services from lengthy negotiation and mobilization process, facilitated **by NGOs**. Outside of the *Sistema Único de Saúde* (SUS).
- SUS financing structure & rules (team composition, equipment, infrastructure) obstacles to providing healthcare services to forest-dwellers.
- **No effective public strategy** for providing healthcare services to riverine families.

EXAMPLE 5: Emergence of common use territory (TUC) on the Rio Manicore, Amazonas

- 1st such territory in Brazil.
- Fraser's PhD fieldwork location (2006–2008, ..2019)
- Fieldwork June 2023
- Meetings w/: community leaders association; NGOs
- Attended workshops
- Visited 5 communities. 15 recorded open interviews with key informants, participant observation.



TUC Manicore next steps

- Support democratic process of developing **Management Plan**
- Apply for money for **Flutuante** from Lancs IMPACT fund
- Second fieldtrip in July 2024 with UFPA team
